
FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972 (ACT No. 54 OF 1972)

REGULATIONS RELATING TO FOODSTUFFS FOR INFANTS AND YOUNG CHILDREN

EXTENSION NOTICE

I, Aaron Motsoaledi, Minister of Health, hereby extend the compliance and transitional measures period set out in terms of Regulation 16 and 17 of the Regulations Relating to Foodstuffs for Infants and Young Children, No R. 991 made in terms of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972), published in *Gazette* number 9868 of 6 December 2012 as follows—

- a. 24 months from date of publication of the Regulations for regulations 2,3,4,5 and 6;
- b. 12 months from date of publication of the Regulations for regulation 7, 8 and 11;
- c. 6 months from date of publication of the Regulations for regulation 9 and 10; and
- d. 36 months from date of publication of the Regulations for transitional measures.

The Minister of Health has in terms of section 15 (7) (b) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act 54 Of 1972) made the regulations in the Schedule.

SCHEDULE


Definitions

1. In this schedule, "the Regulations" means the regulations published under Government Notice No. R991 of 06 December 2012.

Amendment of regulation 9 of the Regulations

2. Regulation 9 of the Regulations is hereby amended by the addition after sub-regulation (2) of the following sub-regulation—

"(3) No person in a health establishment shall accept or give to any other person free or at low cost; supplies or samples of designated products."
