## <u>ltem 5</u>

1. Will this item be applicable to patient and hospital use?

Yes, the item is expected to be used in hospitals and by patients.

2. Are there more specifications available regarding the software requirements, for example should data transfer be wireless or cable?

Kindly indicate whether your device is able to interface with freely available software.

3. There are 2 requirements for software in the specification, 1 for patients and 1 for hospitals, does this means there will be either 2 products awarded (1 for patients and 1 for hospital) or 2 types of software's using the same product?

The specification is only for one item, to be used by both the hospitals and the patients.

4. How will the department validate manufacturers' claims?

As per section 13 of the Special Requirements and Conditions of Contract, the NDoH reserve the right to conduct due diligence on the supplier. This include due diligence audits on the product offered at the discretion of the Department.

5. How will control solutions be procured?

6. The specification asks for an automatic lancing device, as we know the disposable lancet that goes into the lancing device is no longer available to procure from tender, now we find that only disposable safety lancets are available on tender, how will patient get there top up lancets?

The specification includes a lancing device. Bidders to advise requirements of the lancet for their lancing device offered.

7. Could it be that lancing devices are not required, as patients can collect safety lancets from pharmacy?

8. Will local studies be an advantage?

15. What is the minimum tests required per the "long life" battery?

- 17. What operating temperatures are required?

Between 4 and 45 degree Celsius.

18. Why is there no mention of the NHLS being involved in product verification as the custodian of blood testing in the country?

NHLS testing may be considered as an additional Quality Assurance measure in future bid requests.

19. Patient training, please provide more clarity on how this is supposed to take place? Generally, the pharmacists are trained, and they train the patient.
