## ADDENDUM 7: MACLEODS PHARMACEUTICALS (PTY) LTD

Macleods Pharmaceuticals (Pty) Ltd has been awarded a contract for Tenofovir 300mg and Emtricitabine 200mg 28 tablets, under tender no HP13-2019ARV/01, which is supplementary to RT71-2019.

HP13-2019ARV/01 is supplemental to RT71-2019 (Supply and Delivery of Anti-Retroviral medicines to the State for the Period 01 July 2019 to 30 June 2022). The supplemental contract has been created in terms of paragraphs 18.3, 18.7 and 26.2.1 of the Special Conditions of Contract for RT71-2019.

This addendum, therefore, aligns the Price Adjustment awarded on RT71-2019 to HP13-2019ARV/01.
