STORAGE AND PRINTING

The NDOH will not require any storage.

All printed materials for the event will be distributed or couriered to the selected province/district/sub-district or municipality depending on the magnitude of the event. A Frequently asked question/ pamphlet or leaflet focusing on the theme of the event to be produced, translated and distributed at the event. Database for couriering the IEC materials will be provided by the NDOH

CONTENT DEVELOPMENT

Content for information, education, and communication (IEC) material such as posters, pamphlets, leaflets will be developed for a specific event. Content for PSA or jingles for publicity of the event will also be developed by the service provider. All materials should be translated in languages spoken in that particular community where the event is being held. Layout and design of the IEC material will be done by the service provider and approved by the NDOH.

SOCIAL MEDIA

Service providers will be requested to develop content for social media posters for the event. They will also do layout and design of the posters.

The NDOH will also request live streaming of selected events. The NDOH social media team will do the posting pre, during and post the events.

MEDIA BUYING

Media buying will be specific to the event

For coverage of the event the service provider will be requested to provide and Outside Broadcast from SABC or community radio stations.

PSAs or jingles for a week to publicise the event. Radio or jingle script for the event will be developed by the service provider

SIGN LANGUAGE

All events to have a sign language expert from an accredited institution. Ministry led events to be prioritised for sign language interpreting. Interpreting should focus on the formal programme.
